

# **BLUE RIDGE ARABIAN CLASSIC RULES & REGULATIONS**

## **EXHIBITORS MUST SUBMIT A NON-RETURNABLE COPY OF**

## **EACH HORSE'S COGGINS & VACCINE RECORDS WITH THEIR ENTRIES**

1. Horses shown in this division must have been issued a certificate of registration from the Arabian Horse Registry of America, Inc. (or in the case of foreign entry, have been issued a competition visa by the AHR of America), and/or the Canadian Arabian Horse Registry or, if under one year of age, be eligible for registry and registration applied for (Exception AR101 and must be entered under their full registered name.
2. **DISCIPLINE:** Exhibitors are cautioned that any act of discourtesy or disobedience to the officials on the part of the owner, lessee, trainer, groom, rider, driver or their families will disqualify the horse from adjudication. The management reserves the right to remove an owner, lessee, trainer, groom, horse, rider, driver from the show without being liable for compensation or damages. Show management will be charged with the responsibility of enforcing all USEF and AHA rules. Questions not covered are decided by management and are final.
3. **INDEMNITY AND RESPONSIBILITY:** All entries are accepted with the understanding that neither Virginia Horse Center, its officers, the Show, The Show Committee, Show Officials nor any of its sponsors will be held responsible for any loss, damage, or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the show committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage, or injury to any person, animal or property occasioned by him, and the exhibitor shall indemnify the above mentioned parties against any and all loss, damages and liability thus occasioned, including but not limited to any and all legal costs, including attorney fees, which may be incurred as a result thereof. **THE SUBMITTING OF AN ENTRY FORM TO THE SHOW SHALL**
4. **PROTEST:** Must be filed in accordance with the USEF rules and be accompanied by a deposit of \$200 for members or parent(s) of junior exhibitor(s) and \$300 for nonmembers which will be forfeited if the protest is not sustained (See GR603).
5. **PARKING:** No trailers or vehicles will be allowed to be parked in the barn area. No electrical cords may be run from any barn. If found, a hook-up charge of \$50 per night will be charged.
6. **ARENA:** Indoor open THURSDAY 12 noon until 11pm. **NO LUNGING HORSES IN THE INDOOR ARENA, DESIGNATED LUNGING AREA IS LOCATED BEHIND THE WILEY ARENA.** Sizes 125' x 250' - Footing sand/sawdust mix, main and warm-up rings. No person will be permitted to enter the arena, upon the start of the show, except participants in the class, judges and their assistants, show photographer and assistant, show officials and staff. Attendants will not be permitted in the arena unless summoned by the judge.
7. **PROFESSIONAL SERVICES:** by the Show Veterinarian or Farrier outside the ring will be on a Private Fee Basis. The name and phone number of the vet will be posted at the show office.
8. **CALLS FOR CLASSES:** Classes called promptly. Two minute clock begins when the gate opens, the in-gate **MUST** be closed at the end of 2 minutes after the 1st horse enters the ring (GR109.2(a)) If the same horses are entered in back to back classes, a tack hold should be arranged with the paddock. Maximum of 3 minutes allowed. Always check-in with the paddock master.

Problems with mechanical devices like the PA system can happen - paddock calls must be considered a courtesy. It is the responsibility of the exhibitor to be sure his horse is at the gate at the prescribed time. Every effort will be made to maintain a working PA system to carry calls, no protest will be upheld nor will any section be changed on the basis of a PA system malfunction. Management has the right to cancel any class not filled or change classes/arenas in case of bad weather.

9. AGE OF INDIVIDUALS: for show purposes, an individual's age on December 1 shall be maintained throughout the entire year. Born December 1 assumes the greater age of that date.
10. INDEBTEDNESS TO SHOW: Failure to settle Indebtedness to the show will result in being barred from taking part in USEF Recognized Shows until settlement is made. USEF (GR913). Remedies are available to the show under AHA and USEF rules for non-collectability of checks. Show management will assess a fee of \$50.00 plus bank fees, if a check is returned unpaid. Unless, secretary confirms arrangements, each exhibitor who leaves at close of the show without settling any fees, will be assessed a \$25.00 service fee for sending a bill. All fees will be settled at time of checkout.
11. REFUSAL OF ENTRIES: The Show Committee and the Management reserve the right to refuse, accept conditionally or cancel any entry, disqualify exhibitors, prohibit exhibition of entries and remove from the grounds any individual, stable or both without claim for damages. The submitting of an entry form to the show shall constitute an acceptance by each person signing the same of the provisions herein set forth. See USEF GR91
12. ENTRIES: All membership cards for AHA, USEF, USDF, WDAA must be current or a \$25 incomplete entry fee will be charged. (AHA Single Event Memberships and USEF Show Passes are available for purchase on their respective websites). All Horse Registration papers must be current and a Coggins test dated within the last (12 mos) and shot records must be brought to the show. The entry blank provides space for signatures, address of the trainer, owner or agent, rider, driver, handler of each entry. Under age 18 may not sign as trainer, USEF GR906-909 ALL MONEY MUST ACCOMPANY THE ENTRY FORM AND BE PAID BEFORE NUMBERS CAN BE ISSUED (NO OPEN CHECKS. ALL ENTRIES SENT WITH AN OPEN CHECK WILL BE CHARGED A POST ENTRY FEE PER HORSE!!). Absolutely no numbers will be given out without all entries being complete when you check in with the show office.
13. TBA CLASSES: Any class on the AHA Class List or that is recognized by AHA may be chosen, with the approval of show management - except Dressage, Western Dressage, Driven Dressage, Carriage Driving, Combined Training, Cutting, Eventing, UPHA, Reined/Working Cow, Team Penning Classes, etc. TBA's may NOT be used to split a class by age.
14. An OPEN/SIGNED CHECK will be required to add any classes or bedding, etc at the show. Any additional charges must be paid before leaving the show grounds. Any unpaid charges will be invoiced within 30 days and will be assessed a \$25.00 service fee. Failure to pay within 30 days will be considered an unsportsmanlike act and may result in actions taken against such conduct in accordance with USEF rules. There will be a \$50 charge for any checks returned.

15. **PROTECTIVE HEADGEAR:** In accordance with USEF rules, all juniors riding in Hunt Seat Equitation Over Fences and Not to Jump, Hunter Over Fences and Jumper classes must wear protective headgear passing applicable ASTM standards (must be stamped inside helmet) while riding in designated schooling and exercise areas, the show ring and while jumping anywhere on the show grounds.
16. **DRESSAGE EXHIBITORS** please refer to USEF DR 120 for protective headgear rules
17. **SHOWING OUT OF TRAILER: IS NOT PERMITTED.** A day stall fee of \$50 per day will be charged if a regular show stall is not purchased for your horse. You may arrive the evening before to get settled in. If you stay an additional day you must notify the show office. If present when stalls are counted daily you will be billed for that day.
18. **SMOKING:** Smoking in the barns is prohibited. This safety rule will be strictly enforced. Please Note: Fines may be levied.
19. **BEDDING:** Please preorder bedding, if you will be arriving after 8pm on any night you will not receive bedding unless a pre-order was placed with the stable office (then bedding will be waiting for you in your stalls). There will not be anyone on the grounds to distribute bedding after 8pm. Orders for additional bedding must be requested at the VHC barn office daily.
20. **POST ENTRIES:** Pre-Entries close on March 17, 2026. Entries postmarked after this date will automatically be considered Post Entries and assessed the post entry fee as shown in the fee schedule. A United States Postal Service postmark will take precedence over postmarks from private meters, etc. Extra classes for pre-entered horses will not be post entries, however, no horse may be substituted for horses already entered. Entry blanks must be completed and returned before the closing date. Post entry fee will be charged if postmarked after the closing date. **DO NOT MAIL AFTER March 17, 2026 - DO YOUR ENTRIES ONLINE OR BRING WITH YOU TO THE SHOW and CALL Kim Dickinson for STALLS.**
21. **REFUND POLICY:** Withdrawal of entries must be made in writing and accompanied by a vet certificate. Those received before the closing date will be refunded all fees except office fee. After the closing date, until the start of the show, all fees will be refunded except office, one class and one stall fee. Post entry fees will be retained. No refunds on stall fees after closing date. Refund of AHA/USEF fees applies only if the horse isn't shown at all. If Vetting out of the horse's remaining classes, the exhibitor/owner must inform the office at the time the horse is taken out of the last class that it will not be shown again. No Refunds in Sport Horse in Hand, Dressage and Trail classes for any reason!
22. **ENTRY AND SCRATCH POLICY:** Entries being Added **MUST** be made by the end of the session prior to the session being entered, not during breaks, as the office may be closed. Horses entering the ring without prior entry in the office will be charged a \$25 ride thru the gate fee.
23. **MOTORIZED VEHICLES:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor

operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense.

Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hoverboards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties.

24. Show Officials - In the event of illness or failure of a judge or any other official to attend this show or to perform his duties, the show committee reserves the right to substitute an official for the one who was officially designated in the prize list, according to USEF rules.
25. Food Service will be available on the show grounds.
26. Sharps Containers - One sharps container per 50 occupied stalls will be available for the disposal of needles and other sharp instruments in the barns. Competition management may fine any individual including trainers, owners, exhibitors, or other agents up to \$100 for improper disposal of sharps. This includes disposable safety razors!!

27. USEF GR1210.4 NEW IN 2024: PER GR1215.4: For 6 consecutive hours overnight, stabling must have minimal lighting and noise to allow stabled horses adequate rest.

28. SAFESPORT - All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org).
29. Stabling - Permanent box stalls are required for all horses staying overnight. VHC has fireproof barns containing spacious 10'x12' stalls with steel mesh doors and matted floors. Each barn features interior wash racks, and rest rooms. All horses must have a stall. No tie outs. Requests for adjoining stalls from different owners will be honored if all entries are mailed together. NOTHING should be hung from the electrical conduit along the tops of the stalls.
30. **Each Competitor is responsible for supplying the show secretary with correct association numbers** (USEF, AHA, USDF, WDAA) for horse, owner, rider and trainer on show entries. The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

## **USEF MEMBERSHIP STATEMENT**

Life, senior active, and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule:

1. leadline;
2. exhibitions;
3. games and races;
4. classes for 4-H members;
5. walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program);
6. USDF introductory level tests, pas de deux and quadrille classes;
7. assistant handlers in Dressage Sport Horse Breeding classes

**Penalty Policy** In the event the Blue Ridge Arabian Horse Show, its management or officials are fined by any organization owing to an exhibitor's infraction of the rules or requirements, said fine will be charged to the exhibitor plus a 10% penalty.

## **AHA MEMBERSHIP STATEMENT**

EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR.

WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP.

SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS.

EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS.

EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)

### **WDAA Membership Statement**

To be eligible to participate and/or compete as an exhibitor, owner, lessee, agent, coach, or trainer in any Federation-Licensed Western Dressage class or competition, persons must be active members of WDAA or pay a non-member fee equal to the price of an annual membership for each competition. Exception: WDAA membership or non-member fee is not required at a Lite Licensed competition. Lessees are considered owners in connection with this membership requirement. In the event of an entry under multiple ownership, only one owner need be a member or pay a non-member fee. The competition is responsible for listing either the active member or the owner that paid the non-member fee in the results. The competitions will be responsible for forwarding a list of the names of individuals who pay non-member fees at the competition to WDAA with the post competition report. Payment of non-member fees for the purpose of competing does not entitle the individual to any privileges of the WDAA membership.



A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

**Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

**Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

**How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.
